- Opened Meeting at 3:05.
- Scribe's Report (Linda)
  - Minutes were posted 12/8/22 and uploaded to Mensa Connect and the TBM website.
- Asst Loc Sec (Art)
  - Nothing to report.
- Treasurers Report (Kathy)
  - EOY Report we had more income than expenses by about \$1,500.
  - Most other groups don't have large cash balances.
  - Some of the reasons for the surplus include:
    - Low expenses on socials \$750 per social is budgeted for 4 socials per year, and last year they only spent a fraction of that.
    - National support was right in line.
    - We actually received Interest income in Nov and Dec.
    - We haven't had events on which to spend money.
    - We didn't spend during COVID.
    - The cost for newsletter expenses did not go up.
    - We didn't spend what we got from national for our members.
    - There were no games nights. Not spending it fast enough on our members.
  - $\circ$   $\;$  The misc. income on the report is for lapsed member contacts
  - Under expenses, Kathy is listing Ken's Meet & Greets as Member Events instead of refreshments.
    - There is no kitty for the Meet & Greets, like there was for Games Nights
  - There was the expense of \$100 for gift cards for scholarship judges
  - Banking summary: The account balance went up by \$1,500. We have \$19,000 in the bank.
    - Annual funding from National was \$6,600
    - Our biggest expense remains to be the newsletter
    - We budget \$750 per quarter for socials and picnics.
    - Total income \$6,800, outflow \$5,300.
    - National support was reasonably close to what we expected
    - Publicity cost was down
    - There were no refreshment charges
    - Socials were way under budget
    - Scholarship expense was up a little, due to the number of judges
    - For the proposed 2023 budget, she left support from National at \$6,800
    - Cut publicity by \$50
    - Increased scholarship budget for gift cards
    - Cost of printing and postage increased.
    - 2023 budget report so far:

- Actual year to date, Ken had a January meet & greet, 5 people attended and he was reimbursed \$30.
- There have been 3 issues of The Sounding already done
- Our money is right on track
- Thomas offered some suggestions for how we could spend some of our surplus on members
- All values given during the verbal report are approximate. Actual values on the written reports are correct. The written reports are posted to the TBM website.
- Scholarship report (Linda)
  - Deadline for judging round two is Feb. 21<sup>st</sup>. Some judges haven't even started yet.
  - Every region is noting increased essay numbers than in the past. One reason is that the scholarship program is now publicized by The College Board. Students are asked to state where they heard about the program, and many this year have answered with The College Board, which we haven't seen in previous years.
  - This year most scholarship chairs are finding instances of cheating and plagiarism. Some students are using a new app called ChatGPT, which uses AI and machine learning to do things like write essays, term papers, dissertations for college. We have noticed duplicate essays with different names. Also, people submitting more than one essay using two different email addresses.
- Program Officer (Ken)
  - Not present.
  - There were 9 events in February.
  - Bill Loring started the weekly lunch in Carrollwood.
  - Other events included Gourmensans, book club, Meet & Greet.
- Membership Report (Art)
  - There are currently 681 members.
- Testing Coordinator (Lisa)
  - February is ½ Price testing.
  - Need to coordinate test in Pasco.
  - Lisa, Art, and Thomas are all current.
- Publicity (Open)
- Community Outreach (Lisa)
  - Filled all the slots for Mensa Cares for Feeding Tampa Bay which will be on April 1<sup>st</sup>.
  - Motion by Lisa that members who participate in a Mensa Cares event gets a T-shirt, The motion was seconded by Art.
  - $\circ \quad \text{Motion passed}.$
- Loc Sec Report (Lisa)
  - Our Local Group Snapshot is on the Connect Site
  - $\circ$  Dan Tabbert moved and is willing to still be Webmaster until we find a replacement
  - o Open Positions: Publicity, Sight, Calendar and Testing Coordinator
- Social Media (Jacki)
  - One member submitted a request to join with a new profile. This was from a member who was previously posting questionable content. We had already blocked him once.

- Motion to limit people to 1 profile per person submitted by Jacki. The motion carried and is effective as of February 12<sup>th</sup>.
- We will need to update the rules to say members will only be allowed to request one membership.
- Web Master Dan
  - Moved closer to Ocala late November and December.
  - Dan will be transitioning away from the position as webmaster for TBM.
  - He is willing to train someone to replace him as Webmaster for our group. The ideal candidate would be someone who is comfortable with the web. WordPress experience would be a plus. Dan has everything documented.
- Gifted Youth
  - The new person, Andrea.
  - We have to get the word out to the parents to introduce the new Gifted Youth Coordinator
- New Business
  - Spring Picnic
    - Sunday, April 23<sup>rd</sup>, Safety Harbor
  - Banking business.
  - o CD
- TBM used to use National's tax ID number, but to open a CD we needed our own EIN, which Kathy applied for and obtained.
- Proposed to take \$5000 from savings for a CD, then transfer from checking to savings an equivalent amount, which would leave us over \$3,000 in checking.
- Since we have no immediate plans for RG, which is the biggest cash outlay, a 6-month or 12-month CD is feasible.
- Some savings accounts are paying more interest than we are getting, but they usually require a minimum balance of \$10,000 or more.
- Some suggestions from the group:
  - We used to have an annual road trip, like a boat ride.
  - More bowling and billiards events billiards got more responses than bowling the last time around.
- We should make a concerted effort to make events look special.
  - promote it, send out Postcards, which is pricey but effective.
  - We would need to post it early enough for people to put on their calendars.
- Thomas suggested that we could personally contact our members throughout the year, such as sending them birthday cards. That would show we are aware of them personally, which might even get some people to renew their membership
  - It would cost about \$700 to do a card for each member.
- James Gamble is sending out cards to new members. He has only asked for postage - \$36.
- Boat ride
- Invest some of the money in a CD

- We won't need the money until next year
- Kathy made a motion to invest in a CD, Linda seconded. No opposed.
- Jim volunteered to be the next Testing Coordinator.
- We still need 2 new members for ExComm.
- Motion to adjourn 4:35 and the next meeting date was decided for Sunday, April 16<sup>th</sup>.
